SAN JUAN

Record: Challenge 59219 - "San Juan" Position: Closed Pos. M's bk to COH. Footwork: Opposite, directions for M

INTRO:

1---4 WAIT; WAIT; SIDE, CLOSE; SIDE, DRAW (to Semi-Closed pos);
In Closed pos. M's bk to COH wait 2 meas; Step swd twd RLOD on R, close L to R;
Step swd R, draw L to R take ne wgt - end in Semi-closed pos facing LOD;

PART A

- 1---4 WALK, 2; ROLL IN, 2; WALK, 2; PIVOT, 2 (to Closed pos M facing LOD);
 In Semi-Closed pos walk fwd L,R; Swing lead hands down & thru twd RLOD M roll RF
 (W LF) L,R in one full turn to Semi-closed facing LOD; Walk fwd LOD L,R; Take
 Closed pos do a R-face couple pivot L,R to end in Closed pos M facing LOD;
- 5---8 FWD, POINT FWD; BWD, POINT BWD; FWD TWO STEP; FWD TWO STEP (to SCP); In Closed pos step fwd L, point R fwd; Step bwd R, point L bwd; Do 2 fwd two step in LOD L,R/L; R,L/R to end in Semi-Closed pos facing LOD;
- 9--16 REPEAT Action of Meas 1-8 except to end in Closed pos M's bk to COH;

PART B

- 17-20 APART TWO STEP; APART TWO STEP; ROLL(twd ptr), 2; 3, 4 (to Closed pos);

 M moves twd CCH (W twd wall) with 2 two steps L,R/L; R.L/R; M rolls L-face
 (W R-face bk twd ptr L,R; L,R to Closed pos M's bk to COH;
- 21-24 BOX TWO STEP; BOX TWO STEP; CHG SIDE TWO STEP; FACE TWO STEP;

 M step swd L, close R to L/fwd L; Swd R, close L to R/bwd R; Change sides (W twd COH under joined M's L & W's R hands) with 1 two step L, R/L; Turn to face ptr with 1 two step R, L/R to end M's bk to wall with both hands joined momentarily;
- 25-28 REPEAT Action of Meas 17-20 M moving bwd twd wall (W twd COH);
- 29-32 REPEAT Action of Meas 21-24 except to end in Semi-Closed pos facing LOD;

SEQUENCE: INTRO - A - B - A - B - ENDING

ENDING REPEAT ACTION of Meas 1-4 TWICE of PART A; TWIRL, 2; 3, 4(face); ACKNOWLEDGE
