INTRODUCTION: STANDARD. WALT 2 Meas., 4 facing wall, partners facing with trailing hands joined. Meas. 3, partners balance apart; Meas. 4, balance together, ascending. 1978 PAF facing L.F.

DATE: MAY TWENTY NINE, 1945

1. Beginning on W's L, walk slowly away from partner down L/D;
2. Step forward on R toward L/D, step forward on L turning to toward partner, changing hands, close with R, so partners end facing each other (Compare with the cross step, since so it does not)
3. R steps forward toward L/D on L, steps forward on R turning to toward partner, closes with L so partners face L/D, changing hands to W's L & W's R
4. R takes CROSSING WR with partner, facing wall, so he steps on R and touches with L
